Stewards Individual Placements provides individuals with service and career opportunities to strengthen communities and preserve our natural resources. Stewards, in partnership with the National Park Service, are seeking an intern to serve as Community Volunteer Ambassador.

POSITION DETAILS

- Length: position is 50 weeks, 40 hours/week
- Start Date: Monday, February 7th 2022
- Living Allowance: Baseline allowance of \$500/week*
- AmeriCorps Award: \$6,345 (pre-tax)
- Application Due Date: **12/17/2021**, or Until Filled
- Members will attend a week-long, nationwide, National Early Service Training
- Members will receive Public Land Corps Hiring Authority upon completion

ABOUT THE SITE

This special place vibrates with stories of ancient and modern Hawaiian culture and protects the bond between the land and its people. The park also cares for endangered species, some of which exist nowhere else.

POSITION SUMMARY

The Community Volunteer Ambassador (CVA) will support the Volunteers-In-Parks program at Haleakalā National Park, by expanding volunteerism, service-learning, community engagement efforts, and increasing the sustainability of established programs. This excellent opportunity is ideal for an enthusiastic young professional who is deeply committed to help strengthen the bonds between communities and parks.

POSITION RESPONSIBILITIES

- Assist with expanding Haleakalā's Volunteers-In Parks program by recruiting qualified local volunteers from a variety of backgrounds, and with different levels of experience or training
- Enhance the operation of volunteer programs by developing and supporting related projects, activities, and goals
- Exercise responsibility for the job safety and health of all employees and/or volunteers, and ensure conformance with park and service-wide safety programs
- Assist with networking and establishing enduring relationships with local and regional organizations
- Collaborates with Hawaiian groups and local community organizations to accomplish short-term and long-term goals for successful partnerships and community involvement
- Prepare formal and informal interpretative programs for the public
- Attend and participate in workshops, meetings, and conferences, as well as organizing and participating in field gathering efforts of the organization

MINIMUM QUALIFICATIONS

- Good organizational skills and time management practices
- Ability to communicate with people of all ages and cultures
- Ability to work well in a team and collaborate with others on projects
- Self-starter and independent
- Education: High School diploma/GED required
- Between the ages of 18-30 years old (35 years old if you are a veteran)
- Be a U.S. citizen or lawful permanent resident
- Submit proof of a Driver's License and undergo a Federal Background Check, upon selection
- It is very likely that all participants will be required to be fully vaccinated to serve in the 2022 CVA Program. At a minimum participants will be required to get tested weekly if they are not vaccinated. Dates for implementing these requirements are not yet determined, but we expect that compliance will be necessary by the end of 2021.

PREFERRED QUALIFICATIONS

- Familiar with Native Hawaiian language, resources, and culture.
- The ability to speak Hawaiian is preferred, but not required.
- Local applicant
- Effective communication skills
- Some experience engaging with the general public.
- A passion for history, specifically Hawai'i and Haleakalā National Park.
- Proficiency in Microsoft Office
- Experience in social media platforms like Facebook and Instagram.
