ABOUT THE SITE

The George Washington Memorial Parkway was designed for recreational driving. It links sites that commemorate important episodes in American history and preserve habitat for local wildlife. The Parkway, which consists of roughly 25 individual sites, is one of the most highly visited and biologically diverse areas in the NPS.

POSITION SUMMARY

This is a collaborative and dynamic volunteer management position which will support the work of roughly 3,000 volunteers in maintenance, resource management, and interpretive service positions. The CVA will lead on-site volunteer group projects, as well as play a vital role in program planning and administrative support. Acting as a liaison between long serving volunteers, park staff, and partner organizations, the CVA will build community around shared advocacy of natural and cultural resources.

POSITION RESPONSIBILITES

- Maintain and improve long-standing volunteer programs as well as develop new programs through volunteer recruitment, training, scheduling, recognition, and records management
- Act as a primary point of contact and lead during a variety of service events including but not limited to trash cleanups, trail repairs, invasive species removal, and youth service projects
- Research national, regional, and park management tools to recommend program improvements
- Plan service events by identifying possible projects, collaborating with appropriate park staff, coordinating supplies and materials, and staying up to date on national initiatives and requirements
- Promote the volunteer program by creating content for the internal newsletter, park social media, and park web page
- Regularly meet with volunteers and park staff to maintain awareness of changing program needs
- Develop strategies to improve volunteer engagement and management resources

HOUSING
